ESSENTIAL QUALIFICATIONS INCLUDE BEING AN ENROLLED MEMBER OF A FEDERALLY RECOGNIZED AMERICAN INDIAN TRIBE; BEING ENROLLED IN A HEALTHCARE CAREER PROGRAM AT THE UNDERGRADUATE OR GRADUATE LEVEL AT AN ACCREDITED INSTITUTION; HAVING PASSING GRADES IN REQUISITE MAJOR COURSES, WITH A SEMESTER DEMONSTRATION OF ADEQUATE PERFORMANCE; HAVING AN OVERALL PASSING GPA; AND RECEIPT OF THREE REFERENCES. AWARDS ARE COMPETITIVELY PRIORITIZED BY ACCUMULATED DEMONSTRATED PERFORMANCE. THE AWARDEE MUST ATTEST THE AWARD WILL BE USED EXCLUSIVELY THE PURPOSE OF FURTHERING HIS EDUCATION FOR A CAREER IN A HEALTH RELATED FIELD. THE AWARDS ARE FOR ONE TERM AND REAPPLICATION WITH CURRENT TRANSCRIPT DATA IS REQUIRED FOR AN ADDITIONAL AWARD. A FULL-TIME STUDENT RECEIVED \$590 TO \$850 AND A PART-TIME STUDENT \$160- \$250 PER AWARD. THERE IS NO CAP TO THE TOTAL AMOUNT OF AWARDS RECEIVED, BUT FEW EXCEED \$7000 UNLESS THEY GO ON TO MEDICAL SCHOOL.

BESIDES THE EXEMPT ROLE OF A HOSPITAL GIFT SHOP FOR THE CONVENIENCE AND SERVICE TO PATIENTS, STAFF AND PATIENTS; THE AMERICAN INDIAN (AI) ART AND JEWELRY SOLD CONTRIBUTE TO THE CULTURAL COMPETENCY OF PIMC. AN ESSENTIAL ASPECT OF ITS UNIQUE HEALTHCARE OF AMERICAN INDIANS, PIMC'S CULTURAL COMPETENCY IS AN IMPORTANT CRITERIA THAT MUST BE MET FOR ITS NATIONAL JOINT COMMISSION ACCREDITATION. IN THE AI CULTURE THESE ITEMS OF ETHIC JEWELRY AND ART ARE MUCH MORE THAN MERE ADORNMENT, BUT ARE IMPORTANT ASPECTS OF THEIR HERITAGE, CULTURE, SELF-IDENTIFICATION AND SPIRITUALITY. A SIGNIFICANT NUMBER OF THESE ITEMS ARE PURCHASED BY PIMC EMPLOYEES. THE 10% EMPLOYEE DISCOUNT, WHICH THEY RECEIVED, AMOUNTED TO A \$1,149 "GRANT-IN-KIND" TO THEIR CULTURAL SELF-IDENTIFICATION AND THUS PIMCA'S CULTURAL COMPETENCE. PIMCA EMPLOYED 1 PART-TIME GIFT SHOP MGR-BUYER AND UTILIZED 16 VOLUNTEERS.

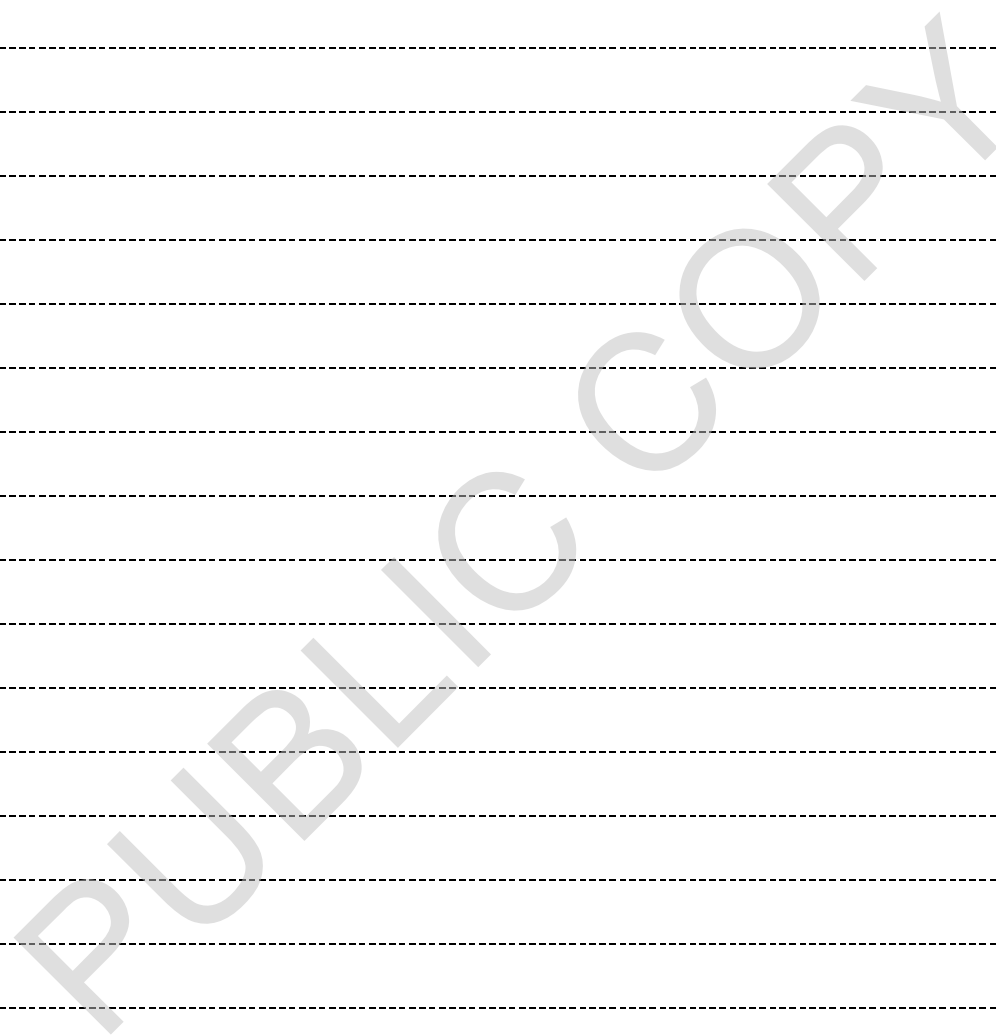
